- Raising the profile of their organisation.

#### **ELIGIBILITY**

Nominations are open to all Commonwealth and ACT Public Sector agencies that are IPAA ACT members. Cross-jurisdictional initiatives are encouraged, provided the lead organisation is an IPAA ACT member and is from the Commonwealth or ACT Public Service.

#### AWARD CATEGORIES

**COLLABORATION** - recognising crossagency and/or cross-jurisdiction initiatives where organisations have worked collaboratively to deliver superior results and outcomes.

**COMMUNITY ENGAGEMENT** recognising initiatives where communities have played a key role in the design of superior services and supports that impact positively on the quality of community life.

**BREAKTHROUGH** - recognising initiatives that develop and apply novel products, processes, services, technologies and/or management practices to create better experiences for the beneficiaries of the breakthrough.

**LEARNING** - recognising initiatives that build the knowledge, skills and capabilities to address complex problems over time.
