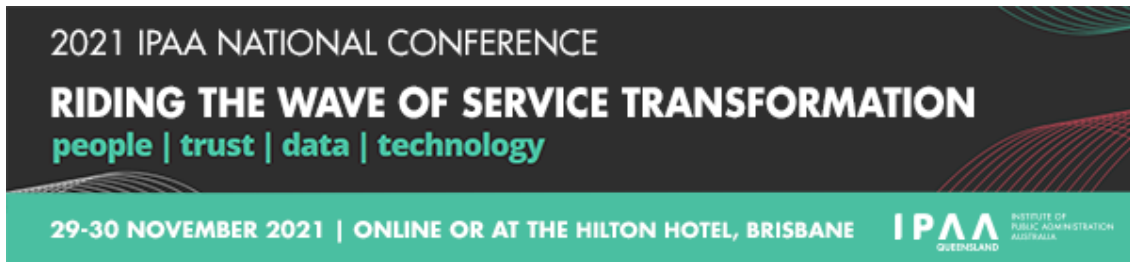

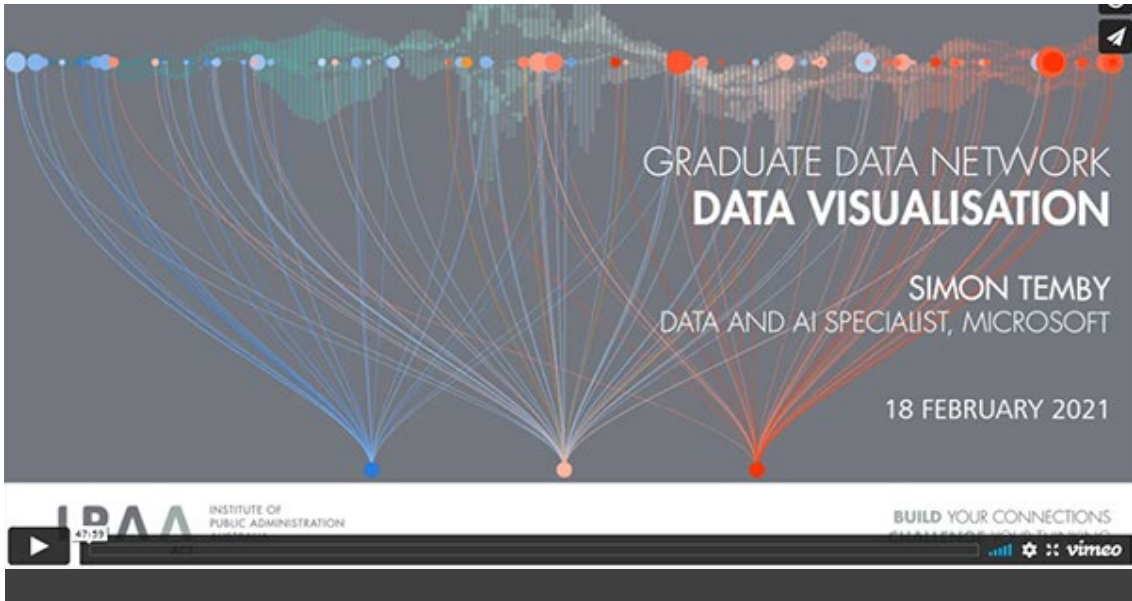
GRADUATE DATA NETWORK | DATA VISUALISATION
