Stuart Robert has been the Federal Member for the northern Gold Coast seat of Fadden since November 2007.

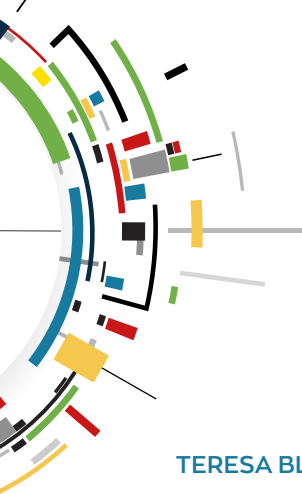
He is a passionate advocate for the northern Gold Coast in Canberra, working hard to influence the decisions affecting local residents in the community.

TERESA BLAIR Assistant Secretary Data Analytics, Department of Defence



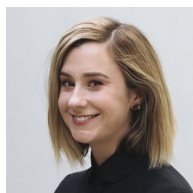
Teresa is currently the Assistant Secretary Data Analytics, responsible for the implementation of the Defence Data Strategy and establishment of the new Data Division.

In 2020, Teresa came on board to support the Associate Secretary by leading the development and launch of the Defence Transformation Strategy. The Transformation Strategy is the accompaniment to the 2020 Defence Strategic Update and the 2020 Force Structure Plan, and sets out the strategic guidance for enduring transformation and reform of the Defence enterprise.

Following the launch of the Transformation Strategy in November 2020, Teresa established the new Enterprise Analysis Branch.

ASSOCIATE PROFESSOR ELLEN BROAD School of Cybernetics, Australian National University



Ellen is an Associate Professor with the School of Cybernetics, founded by Distinguished Professor Genevieve Bell at the Australian National University, where she focuses on designing responsible, ethical and sustainable AI. She has written for publications including The Guardian, New Scientist, Harper's Bazaar and Griffith Review and is a regular keynote speaker and commentator on technology issues. She is the author of Made by Humans: the AI Condition (Melbourne University Publishing, 2018) and co-designer of a board game about open data, alongside ODI Vice President Jeni Tennison, called Datopolis that is being played in 19 countries.

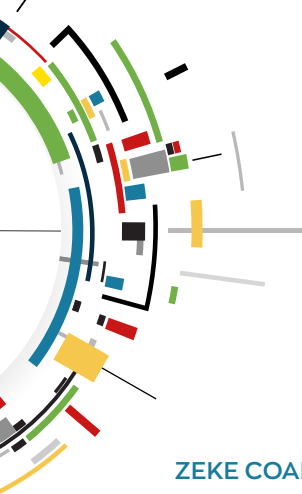
FLORA CARAPPELLUCCI Group Manager, Data and Evaluation Department of Social Services

He works closely with states, territories, other Australian Government agencies, and international partners to ensure those national datasets can be used appropriately and across borders. Simon's 20-year career includes experience with Geoscience Australia, PSMA Australia, and the United Nations, and membership of national and regional working groups. Simon was Chair of the Intergovernmental Committee on Surveying & Mapping for Australia and New Zealand between 2018 and 2020.

DR GORDON DE BROUWER PSM President, IPAA National



Gordon de Brouwer is Professor of Economics, jointly appointed to the Crawford School of Public Policy and College of Business and Economics. He is committed to public value, high-quality policy and implementation, and effective government.

Gordon has about 35 years' experience in public policy and administration in Australia, including as Secretary (CEO) of the Department of the Environment and Energy (2013-17) and senior roles in the Department of the Prime Minister and Cabinet (including Associate Secretary of Domestic Policy Group and G20 Sherpa, 2008-13), Treasury (2002-08), ANU (Professor of Economics, 2000-02) and the Reserve Bank of Australia (1991-99).

Gordon is a Director of the Australian Nuclear Science and Technology Organisation (ANSTO)(including Chair of the Risk and Audit Committee) and the Committee for the Economic Development of Australia (CEDA). He is a member of the Advisory Board of the Nature Conservancy Australia and the Reef Resilience and Adaptation Program. He is National President of the Institute of Public Administration Australia, Chair of the Australian National Committee of the Pacific Economic Cooperation Council (AusPECC), and a facilitator in Jeff Whalen Learning Groups for senior public servants in Australia and New Zealand. He is a senior advisor in the Economics Program at the Center for Strategic and International Studies, Washington. D.C.

Gordon has a PhD in economics from the Australian National University. He was awarded a Public Service Medal and made a Knight in France's Legion of Honour for his work on G20 and public service.

Louise Gates is Group Head of the Data Strategies and Discovery Group, whose core functions include leading the development of the Institute’s strategies for acquiring, managing, and integrating major data assets (linkage), managing key relationships across government in support of the public sector data agenda; reporting on veterans’ health and welfare, including suicide monitoring; and leading the development, monitoring, and reporting of information and statistics on maternal and perinatal health. Ms Gates is also the Chief Statistical Officer of the Institute.

Louise has been working in data and particularly health data related roles for over 20 years, primarily at the Australian Bureau of Statistics. She has a Bachelor of Science with 1st class honours majoring in Statistics, a Masters in Statistics and is currently studying a Masters in International Population Health.

CATHRYN GEIGER Chief Data and Analytics Officer, Department of Agriculture, Water and the Environment



Cathryn Geiger is the Chief Data and Analytics Officer in the Department of Agriculture Water and Environment. She heads up the newly created Data and Analytics Office. The Office provides a central hub to deliver geospatial and analytics services, as well as uplift capability across the department. Ms Geiger is an experienced SES leader having driven policy reforms in several government departments including infrastructure, regional development and Prime Minister and Cabinet. She has a passion for continuous improvement through genuinely connecting to stakeholders.

DR PHILIP GOULD First Assistant Secretary, Health Economics and Research Division, Department of Health



Dr Phillip Gould is the First Assistant Secretary, Health Economics and Research Division in the Department of Health. In this role, Phillip is passionate about strengthening the Department’s evidence based approach to decision making, through funding new health research, improving the use of health data across the Commonwealth and State and Territories and economic modelling.

Phillip’s team is responsible for the continued development of the Department’s strategic economic outlook across Australia’s health system and providing specialised modelling, costings for the Commonwealth’s health and aged care programs. Additionally, Phillip has oversight of the administration of the Medical Research Future Fund 10 year plan and Biomedical Translation Fund.

DR DAVID GRUEN AO Australian Statistician



Dr David Gruen AO was appointed Australian Statistician on 11 December 2019. As Agency Head of the Australian Bureau of Statistics, he is accountable for the functions and operations of the Bureau.

David was previously the Deputy Secretary, Economic and Australia's G20 Sherpa at the Department of the Prime Minister and Cabinet. Before joining the Department in September 2014, he was Executive Director of the Macroeconomic Group at the Australian Treasury. David joined the Treasury in January 2003, before which he was the Head of the Economic Research Department at the Reserve Bank of Australia from 1998 to 2002.

Before joining the Reserve Bank, David worked as a research scientist in the Research School of Physical Sciences at the Australian National University.

With financial support from a Fulbright Postdoctoral Fellowship, David was visiting lecturer in the Economics Department and the Woodrow Wilson School at Princeton University from August 1991 to June 1993. He holds PhD degrees in physiology from Cambridge University, England and in economics from the Australian National University.

David was appointed an Officer of the Order of Australia (General Division) in 2022 for distinguished service to public administration, to economic research, to business, and to education.

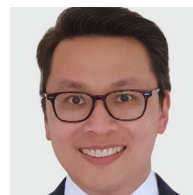
HESHAN INAMALUWA Project Lead, Graduate Data Network Forum

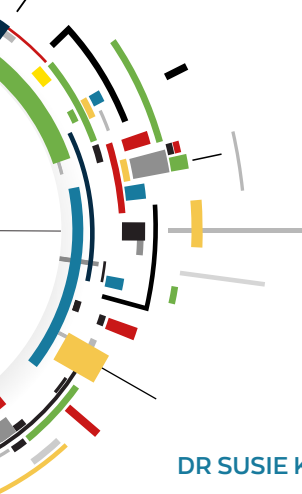

ANDREW LALOR Assistant Secretary, Data and Digital Branch, Department of the Prime Minister and Cabinet



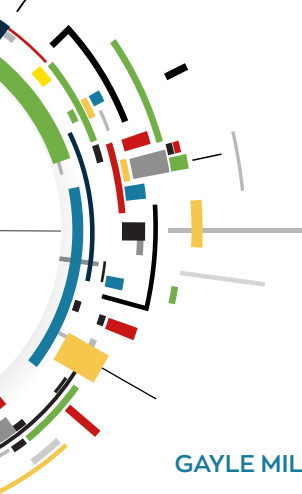

DR JOSHUA MELTZER Senior Fellow, Global Economy and Development Program, Brookings Institution



Dr Meltzer is a senior fellow at the Brookings Institution. His research focuses on international economic relations and the intersection of technology and trade policy. He co-leads the Forum on Cooperation in AI (FCAI) along with Cameron Kerry - a multistakeholder track 1.5 dialogue with government officials from seven countries (US, EU, Canada, UK, Singapore, Japan and Australia) as well as AI experts from industry and academia. He also leads the USMCA initiative which focuses on how USMCA can strengthen international cooperation in North America. Meltzer has testified before the U.S. Congress, the U.S. International Trade Commission and the European Parliament. He was an expert witness in the Schrems II litigation in Europe on data flows and privacy and a consultant to the World Bank on trade and privacy matters. He is a member of the Australian government's National Data Advisory Council as well as the Australian government's AI Action Plans Committee. Meltzer teaches digital trade law at Melbourne University Law School and has taught digital trade law at the University of Toronto Law School as an adjunct professor and ecommerce and digital trade at the UK Foreign, Commonwealth and Development Office diplomatic academy. Before Brookings, Meltzer was a diplomat at the Australian Embassy in Washington D.C. and prior to that an international trade negotiator in Australia's Department of Foreign Affairs and Trade. Meltzer has appeared in print and news media, including the Economist, the New York Times, CNN, Bloomberg the Asahi Shimbun and China Daily. Meltzer holds an S.J.D. and LL.M. from the University of Michigan Law School, Ann Arbor and law and commerce degrees from Monash University in Melbourne, Australia.

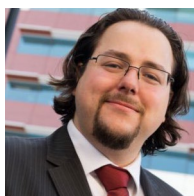
GAYLE MILNES National Data Commissioner Designate

In these roles she has driven nationally significant reforms, strengthened enterprise data governance and management and been a heavy data user across a range of sectors.

DR BENJAMIN MITRA-KAHN Program Manager, Household Income and Expenditure Data Branch, Australian Bureau of Statistics

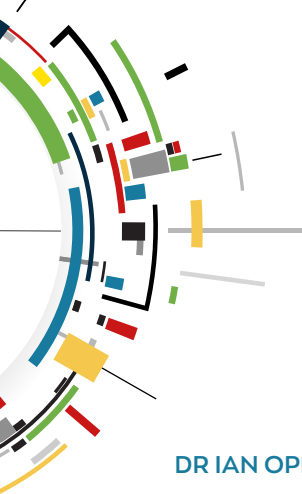


Dr Ben Mitra-Kahn is an economist who has served as the economic advisor to the UK Intellectual Property Office (2009-12), Chief Economist at IP Australia (2012-21), and is currently the program manager of the Household Expenditure and Income Data Branch at the Australian Bureau of Statistics. He has published research on the economics of copyright and patents, as well as development and the history of national accounts. Before joining the UK civil service he spent time in academia, and running his own business. He holds a PhD in Economics from City University London, M.Sc. in Development Economics from the School of Oriental and African Studies, University of London and B.Sc. (Hons) Economics from Royal Holloway, University of London.

CELIA MOSS Program Manager, Data Strategy, Integration and Services Division, Australian Bureau of Statistics



Celia Moss has over 30 years experience working with data and statistics, both in Australia and internationally. She is currently the Program Manager of the Data Strategy and Services Branch at the Australian Bureau of Statistics, and is involved in a wide range of initiatives across the data system - including development of infrastructure for safe and secure data sharing, integration and analysis; establishment and enhancement of integrated data assets for research; and strategies to build social licence and trust in ABS and wider government use of data. Prior to her current role, Celia has held leadership roles in social statistics, the Census of Population and Housing, and organisational transformation.

DR IAN OPPERMANN NSW Government's Chief Data Scientist



Dr Ian Oppermann is the NSW Government's Chief Data Scientist working within the Department of Customer Service. He is also an Industry Professor at the University of Technology Sydney (UTS). Ian has been recognised as a Global Leader in Data and Analytics (Corinium's Global Top 100 in 2020 and 2022) spanning the domains of government, industry, academia and standards. Ian has an MBA from the University of London and a PhD in Mobile Telecommunications from Sydney University. Ian is a Fellow of the Institute of Engineers Australia, a Fellow of the IEEE, a Fellow of the Australian Academy of Technological Sciences and Engineering, a Fellow of the Royal Society of NSW, is a Fellow and Immediate Past President of the Australian Computer Society, and a graduate member of the Australian Institute of Company Directors. He is Chair of Australia's IEC National Committee and JTC1, the NSW AI Review Committee and the NSW Smart Places Advisory Council.

PROFESSOR SALLIE PEARSON Head of the Medicines Policy Research Unit, UNSW Sydney



Professor Sallie Pearson heads the Medicines Policy Research Unit at the Centre for Big Data Research in Health, UNSW Sydney. She is also the Director of the NHMRC Centre of Research Excellence in Medicines Intelligence. Sallie is a leading authority in the conduct of population-based research using routinely collected data, pertaining particularly to the quality use of medicines. Sallie has led national and international studies leveraging 'big health data' to generate evidence about the use, benefits and safety of prescribed medicines in routine clinical care. Sallie is long-standing advocate for the safe and productive use of data to benefit the Australian community. 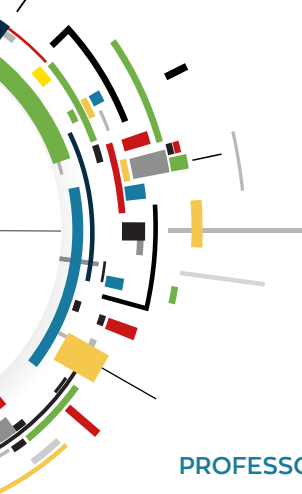
DR LOUISE RAWLINGS Head, BITRE, Department of Infrastructure, Transport, Regional Development and Communications

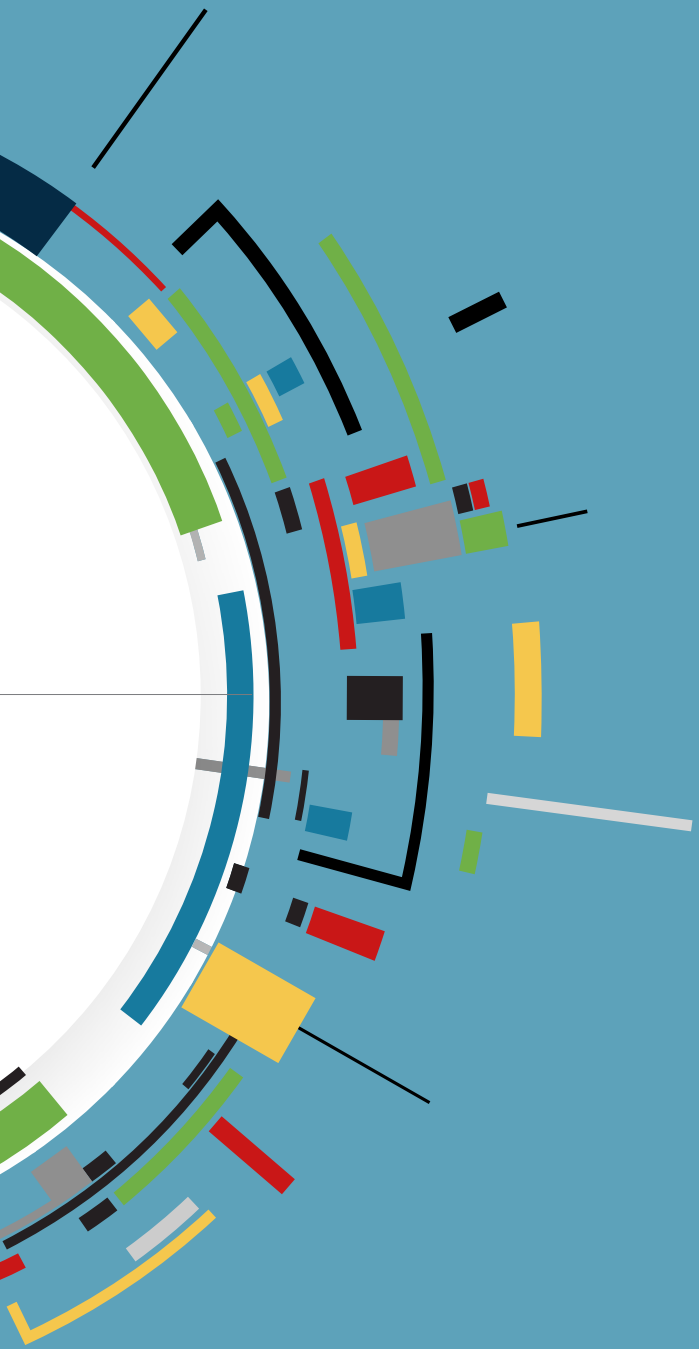
JESSICA ROBINSON Assistant Secretary - Policy, Engagement and Governance, The Treasury
