IPAA SURVEY RESULTS | ATTENDING FACE-TO-FACE EVENTS



Thanks to everyone who participated in last week's survey on your interest in attending physical events – we were blown away by the response! Here's a snapshot of some of what you shared with us:

- Attendance 82% are keen to attend events when it's safe to do so, in line with ACT government guidance.
- Audience size 81% are relaxed about audience size, so long as we follow physical distance guidelines.
- **Topic** a notable piece of feedback is that only 18% of you want to attend events with a COVID-19 focus!

We also asked why people are keen to attend IPAA events:

- 43% to engage in discusison about the public sector.
- 34% for the opportunity to network with colleagues.
- 19% to get out of the house and back to normality.

We'll take the feedback on board and use it to shape our program for the rest of the year and beyond. Watch this space!


